

# SHOTGUN TRAINING PROGRAMME 2011

## Continuous Shotgun Training Course(Apr to Jun 2011)

### (a) Application Procedure

Registration will be entertained on a “**first-come-first-serve**” basis.

Applicant should return the completed application form, HKID card copy together with crossed cheque made payable to ‘Hong Kong Shooting Association’ at **Room. 2011, Olympic House, 1 Stadium Path, Causeway Bay, Hong Kong.**

### (b) Course Fees

**HK\$ 900 per person** (HK\$750 for members of the Hong Kong Gun Club)

Inclusive of lecture, live practice (40 rounds of shot shells) and provision of ear and eye protection, shooting vest and shotgun.

### (c) Notes to Applicant

- (1) All applicants must be age 15 or above and completed and passed the Intermediate Shotgun Training Courses OR completed the Continuous Session within the past 6 months.
- (2) Applicants aged below 18 must seek consent from their parent/guardian or person authorized by their parent/guardian.
- (3) Applicants must produce their HKID card on the day of the activity for verification.
- (4) The Organizer reserves the right to refuse any application or adjust dates of activities if necessary.
- (5) Course fee is non-refundable.
- (6) Arms and ammunition can only be used under the supervision of arms instructor.
